

**THE CORPORATION OF THE TOWN OF GREATER NAPANEE
BY-LAW NO. 2023-0033**

A By-law to amend By-law No. 06-14 (By-law to regulate the use of the waste management system for the Town of Greater Napanee) to increase certain fees

WHEREAS the Council of the Town of Greater Napanee passed By-law No. 06-14, being a by-law to regulate the use of the waste management system for the Town of Greater Napanee on March 27, 2006;

AND WHEREAS Council amended By-law No. 06-14 on January 13, 2020 to increase the cost of bag tags and subsequently amended By-law No. 06-14 on June 23, 2020 to amend Schedule E regarding tipping fees for the Waste Disposal and Transfer Sites;

AND WHEREAS Council deems it expedient to amend By-law No. 06-14, as amended, to increase the fee of bag tags from \$3.00 to \$4.00 and to increase the fee for disposal of bulky items;

AND WHEREAS Council deems it expedient to amend By-law No. 06-14, as amended, to reflect the use of a special area levy to partially fund curbside garbage and recycling collection services;

AND WHEREAS public notice regarding these fee increases has been provided;

NOW THEREFORE the Council for The Corporation of The Town of Greater Napanee hereby enacts the following amendment to By-law No. 06-14, as amended:

1. That Part 2 - Setting Out Waste for Collection, Clause 2.F.3.(2) shall be amended by deleting the said clause and replacing it with;

“The fee for each sticker or tag is shown in Schedule “I”, which shall be paid in advance to the Town. The payment of such fee shall be made by the purchase from the Town or its authorized agents of stickers or tags in multiples of 5.”

Schedule “I” - Fees for the Town’s Stickers/ Bag Tags is attached hereto.

2. That Schedule ‘E’ of By-law No. 06-14 - Tipping Fees for the Town’s Waste Disposal Sites be hereby amended by deleting the said Schedule ‘E’ and replacing it with the Schedule ‘E’ - Tipping Fees for the Town’s Waste Disposal and Transfer Sites attached hereto.
3. That this by-law shall come into force and take effect on the 1st day of May 2023.
4. That By-law No. 2020-0003 and 2020-0036 be hereby repealed.

Read a first and second time and finally passed this 25th day of April, 2023.

**Schedule "E" to By-law No. 06-14
Tipping Fees for the Town's Waste Disposal and Transfer Sites**

The below noted fees will apply to all non-commercial waste that is generated from a residence within The Town of Greater Napanee, to be disposed of at the South Fredericksburgh Waste Disposal Site and/or the Roblin Waste Transfer Station.

1. All residential household domestic waste packaged in a refuse bag/container not exceeding:
 - A size of 36 inch in height by 24 inch in diameter or a container with a capacity of 27.5 gallons (125 litres).
 - Oversized bags/containers of domestic waste will be charged at an additional bagged rate.

Charge: \$6.00; or
a Greater Napanee Bag Tag plus an additional \$2.00

2. All residential bulky waste shall be calculated at a rate of \$0.45 cents per cubic foot:
 - A minimum fee of \$15.00 will be applied to all loads under 32 cubic feet.
 - Measurements will be based upon the site attendant's discretion and will be calculated based upon the greatest vertical and horizontal measurements.

Formula: (Length x Width x Height) will determine the quantity in cubic feet to be multiplied by \$0.45. All fees will be rounded to the nearest dollar.

3. Additional surcharges will be applied to all residential large items as per below:
 - \$10.00 each for item (i.e. box spring, mattress, sofas/chairs, cabinetry, dressers, and other accepted items that are not broken down.)
4. The following recyclable items are accepted at both South Fredericksburgh Waste Disposal Site and/or the Roblin Waste Transfer Station free of charge:
 - Electronic waste
 - Scrap metal
 - Biodegradable bagged leaves & yard compost
 - Brush less than 3 inch in diameter
5. The following recyclable items are accepted at both South Fredericksburgh Waste Disposal Site and/or Roblin Waste Transfer Station at a fee of \$5.00 per load:
 - Paper/Cardboard
 - Metals/Plastics/Glass

**Schedule "I" to By-law No. 06-14
Fees for the Town's Stickers/Bag Tags**

1. The fee for an individual bag tag is \$4.00, including all applicable provincial and federal taxes.
2. In addition to the sale of individual bag tags, the Town may, by by-law, establish an annual fee for residential garbage collection, to be levied on the municipal taxes. The Town may also mail out a set number of bag tags to reflect the residential garbage collection covered by such annual levy.
