Regular Meeting of Council for March 26, 2024

Gifting Agreement with Kingston Community Health Centres

Council received a report for information on the Gifting Agreement with Kingston Community Health Centres (KCHC). The agreement between the Town and KCHC replaces the past practice of Forgivable Loans to incentivize family physicians to locate in Greater Napanee. In the partnership created by this Gifting Agreement, KCHC will employ the medical professionals as well as human resources and administrative support. This model allows the medical professionals to focus their energy on patient care.



By-law Enforcement Services Contract

Council received a report on the By-law Enforcement Services Contract. Council authorized staff to enter into a service contract with Frontenac Municipal Law Enforcement Inc. to provide enforcement services for parking, yard maintenance, and other municipal by-laws for the remainder of 2024 at a cost of up to \$47,350 including HST.

Centre Street Boat Launch and Parking Lot

Council endorse the amended parking lot maintenance and enforcement strategy as presented in the report and noted the following changes to be implemented:

- Beginning in spring 2024, the central concrete barriers with no-parking signage will remain in place year round as the standard practice.
- The docks for the boat launch will be removed in the winter and installed in the spring at the direction of the Manager of Facilities, based on the long-term weather forecast and staffing schedule.
- Beginning in winter 2024, during the period where the boat launch docks are removed, the 'boat trailer parking only' signage will be bagged to indicate that boat trailer parking enforcement will be done on a seasonal basis.



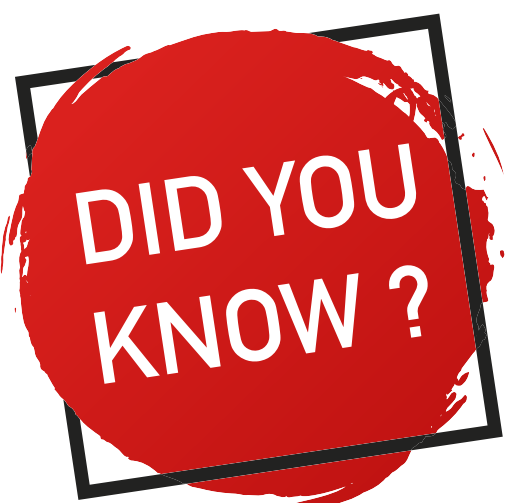
Council Advisory Committees Annual Review

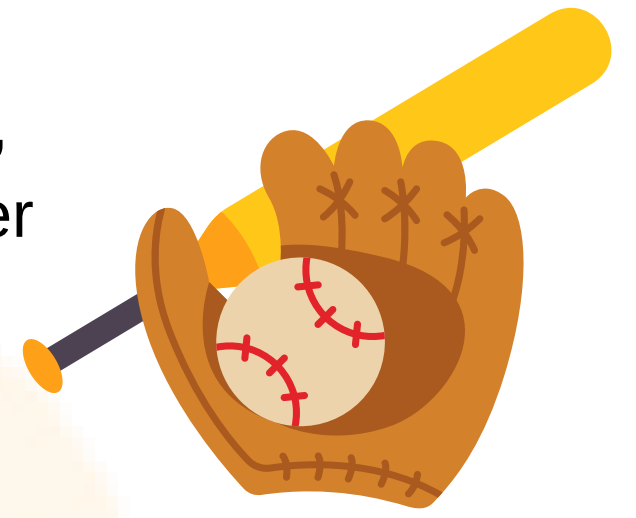
What's Happening in Our Municipal Departments:

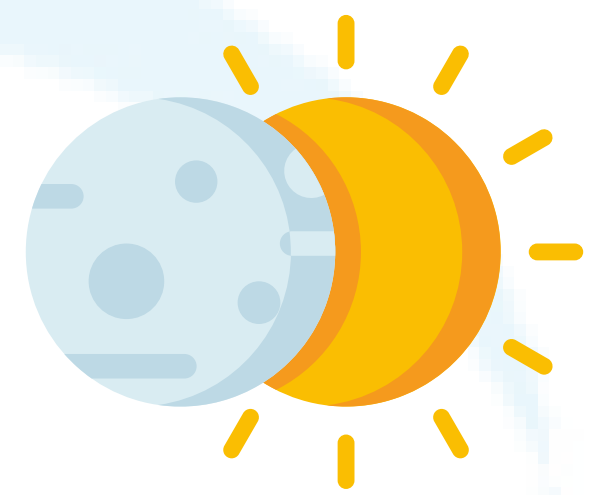


Financial Services

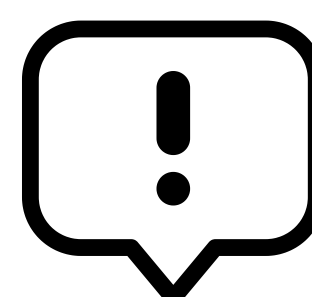
