INTERMENT AUTHORIZATION

1. Compliant with the Cemetery Act and Regulations for Ontario, specifically Ontario Regulation 130/92, s. 8., no interment of human remains shall occur within a lot, other than the remains of the Interment Rights Holder, without the written consent of the Interment Rights Holder. In respect thereof, a legal representative, or as applicable under the laws of Ontario, the Residuary Clause of a Will or Intestate Succession of the Interment Rights Holder, all or a majority of the beneficiaries or heirs-at-law.

2. Whereupon an interment must be made and appropriate consents of the majority, but not of all those entitled to interment rights of the lot or plot are obtained, Cemetery Authorities may upon submission of this document honor the interment request and allocate an interment site for interment of the deceased. The allocation of an interment site does not convey upon any person ownership of interment rights. Therefore, it shall be understood by each party requesting and authorizing interment, that upon signature of this document.
 - a. A solemn declaration is made that the deceased has a legal right to be interred in the lot or plot of the Interment Right Holder as appears in the reasonable of the Cemetery.
 - b. Each signature is representative of a person having legal interest in the Interment Rights the lot or plot, as set forth in section 1., and that every reasonable effort has been made to contact others that may have a legal interest.
 - c. Each party accepts financial and legal responsibility for the execution of interment request and authorization of same.

3. *Authorities for the Township strongly recommend that where appropriate, each party claiming to have the legal right to authorize interment, who are the successors by Ontario Law of the Registered Interment Rights Holder(s) obtain Legal Counsel.*
