SWITZERVILLE ROAD AT THE WEST SIDE OF CONC. 7 LOT 21, NORTH TO COUNTY ROAD 2, EAST TO INCLUDE THE SOUTHERLY PORTION OF LOT 21 TO LOT 30 TO THE LOYALIST TOWNSHIP BOUNDARY, SOUTH TO LAKE ONTARIO, WEST ALONG LAKE ONTARIO, INCLUDING ALL OF FORMER SOUTH ADOLPHUSTOWN, EAST ALONG THE SOUTH SIDE OF HAY BAY TO THE EAST SIDE OF CONC. 4 LOT 12 FORMER NORTH FREDERICKSBURGH, NORTH ALONG THE EAST SIDE OF CONCESSIONS 3 & 4 LOT 12 TO NORTH END LOT 13 CONC. 3 FORMER NORTH FREDERICKSBURGH, EAST TO COUNTY ROAD 8, EAST TO THE CENTRE LINE OF THE OLD HAMBURG ROAD, NORTH ALONG THE EAST SIDE OF THE OLD HAMBURG ROAD TO SWITZERVILLE ROAD, EAST ALONG THE CENTRE LINE OF SWITZERVILLE ROAD

**WARD 2**

THE MOST WESTERLY TIP OF NORTH ADOLPHUSTOWN WEST SIDE OF LOT 26 CONC. 4 OF FORMER ADOLPHUSTOWN, IN A NORTH EASTERLY DIRECTION FOLLOWING THE SHORE LINE TO THE EAST SIDE OF LOT 16 CONC. 6 (FORMERLY NORTH FREDERICKSBURGH), SOUTH TO THE CENTRE LINE OF PALACE ROAD, NORTH EASTERLY TO THE CENTRE LINE OF COUNTY ROAD 2, EASTERLY TO THE EAST SIDE OF LOT 20, CONC. 7, SOUTHERLY ALONG THE EAST SIDE OF LOT 20 TO THE CENTRE LINE OF SWITZERVILLE ROAD, WESTERLY ALONG THE CENTRE LINE OF SWITZERVILLE ROAD TO THE CENTRE LINE OF THE OLD HAMBURG ROAD, SOUTHERLY ALONG THE OLD HAMBURG ROAD TO THE INTERSECTION OF THE CNR LINE, WESTERLY ALONG THE NORTHERN BOUNDARY OF THE THIRD CONCESSION OF FORMER NORTH FREDERICKSBURGH TO THE SOUTH WEST CORNER OF LOT 13 CONC. 6, SOUTH BETWEEN THE BOUNDARIES OF LOT 12 & 13 TO HAY BAY, WESTERLY ALONG THE NORTH SHORE OF HAY BAY, INCLUSIVE OF ALL ISLANDS IN THE BAY, TO THE SOUTH WESTERLY TIP OF NORTH ADOLPHUSTOWN

COMMENCING WHERE THE NORTH SHORE OF THE NAPANEE RIVER INTERSECTS WITH THE EXTENSION OF THE BOUNDARY BETWEEN LOT 19 AND 20, CONC. 1 (FORMER TOWNSHIP OF RICHMOND); WEST ALONG THE SHORE OF THE NAPANEE RIVER, INCLUDING ALL ISLANDS, TO THE DESERONTO BOUNDARY; NORTH TO THE TWEED TOWNSHIP BOUNDARY, ALONG THE EAST SIDE OF THE TYENDINAGA TOWNSHIP BOUNDARY; EAST ALONG THE SOUTH SIDE OF THE TWEED TOWNSHIP BOUNDARY, TO THE STONE MILLS TOWNSHIP BOUNDARY; SOUTH TO THE CENTRE LINE OF COUNTY ROAD 1 EAST; WEST ALONG COUNTY ROAD 1 EAST TO THE CENTRE LINE OF HIGHWAY 401; WEST ALONG HIGHWAY 401 TO THE CENTRE LINE OF THE UNNAMED ROAD ALLOWANCE THAT IS THE SOUTHERLY EXTENSION OF PRINGLE=S SIDE ROAD SOUTH OF HIGHWAY 401; SOUTH TO THE CENTRE LINE OF COUNTY ROAD 1 WEST; EAST ALONG COUNTY ROAD 1 WEST TO THE EAST SIDE OF LOT 18, CONC. 2, (FORMER TOWNSHIP OF RICHMOND); SOUTH TO THE GRAND TRUNK RAIL LINE; WEST ALONG THE GRAND TRUNK RAIL LINE TO THE EAST SIDE OF LOT 16, CONC. 2; SOUTH TO THE CENTRE LINE OF BRIDGE STREET WEST; EAST ON BRIDGE STREET WEST TO THE EAST SIDE OF LOT 19, CONC. 1 (FORMER TOWNSHIP OF RICHMOND); SOUTH TO THE NAPANEE RIVER.

**WARD 4**

COMMENCING WHERE THE SOUTH SHORE OF THE NAPANEE RIVER INTERSECTS WITH THE EXTENSION OF THE BOUNDARY BETWEEN LOT 19 AND 20, CONC. 1 (FORMER TOWNSHIP OF RICHMOND); NORTH TO BRIDGE STREET WEST; WEST ALONG THE CENTRE LINE OF BRIDGE STREET WEST TO THE BOUNDARY BETWEEN LOT 16 AND 17, CONC. 1 (FORMER TOWNSHIP OF RICHMOND); NORTH TO THE OLD GRAND TRUNK RAIL LINE; EAST ALONG THE RAIL LINE TO THE BOUNDARY BETWEEN LOT 18 AND 19, CONC. 1 (FORMER TOWNSHIP OF RICHMOND); NORTH TO COUNTY ROAD 1; WEST ALONG COUNTY ROAD 1 TO THE SOUTHERLY EXTENSION OF PRINGLE SIDE ROAD; NORTH TO HIGHWAY 401; EAST ALONG HIGHWAY 401 TO CENTRE STREET (HIGHWAY 41); SOUTH ALONG THE CENTRE LINE OF CENTRE STREET (HIGHWAY 41) TO THE CENTRE LINE OF COUNTY ROAD 9; WEST TO THE BOUNDARY BETWEEN LOT 16 AND 17, CONC. 6, (FORMER TOWNSHIP OF NORTH FREDERICKSBURGH); NORTH TO THE SOUTH SHORE OF THE NAPANEE RIVER; WEST ALONG THE SOUTH SIDE OF THE NAPANEE RIVER TO THE POINT OF ORIGIN.

NORTH OF THE CENTRE LINE OF PALACE ROAD, EAST OF THE CENTRE LINE OF CENTRE STREET (COUNTY ROAD #41), NORTH TO THE CENTRE LINE OF HIGHWAY 401, EAST TO NEWBURGH ROAD (COUNTY ROAD 1), EAST ALONG COUNTY ROAD 1 TO THE LOYALIST TOWNSHIP BOUNDARY, SOUTH ALONG THE WESTERN BOUNDARY OF LOYALIST BOUNDARY TO HIGHWAY 401, EASTERLY FROM THE 401 TO THE WEST SIDE OF LOT 21 CONC, 7 (FORMER NORTH FREDERICKSBURGH) AT COUNTY ROAD 2, NORTHWEST ALONG THE CENTRE LINE OF COUNTY ROAD 2 TO THE CENTRE LINE OF PALACE ROAD, WEST ALONG THE CENTRE LINE OF PALACE ROAD TO THE CENTRE LINE OF CENTRE STREET
