THE UNDERSIGNED acknowledges that the Board may place any bills that are ninety (90) days or more in arrears from the due date on the Municipal Tax Roll for collection as provided for in the public Utilities Act R.S.O. 1980 as amended.

The Board agrees to use reasonable diligence in supplying a regular and uninterrupted supply of water and sewer services but will not be liable for damages to the customers for reason of failure to do so no matter however caused.
