Council Highlights

Regular Meeting of Council for December 9, 2025

Deputation - Habitat for Humanity Kingston Limestone Region

Council heard a presentation from Habitat for Humanity on a proposal for a housing partnership between their organization and the Town, and their request for financial support. Council directed staff to bring back a report regarding the financial implications of the proposal.



Municipal Support Resolution Request (Carbon Free - CF Napanee Storage)

Council received a report on a Municipal Support Resolution Request (Carbon Free - CF Napanee Storage). Council denied the requested Municipal Support Resolution being requested under the IESO LT2 RFP on the following grounds:

- Limited opportunity for meaningful engagement with Council and the community prior to the submission deadline.
- Feasibility review does not confirm a clearly developable area consistent with the proponent's proposal.
- Uncertainty if the project could be successfully constructed, given identified environmental and geotechnical constraints.

CN Spur Line - Land Sale Negotiation Mandate - Closed Session Direction

Council received correspondence on the CN Spur Line - Land Sale Negotiation Mandate during closed session. Any decision in the future regarding the CN Spur Line will be made during a public meeting.

Solid Waste By-law Update

Council received a report on a Solid Waste By-Law Update. Council directed staff to bring back a draft Solid Waste By-law that incorporates the recommendations outlined in the report along with any additional feedback for consideration at an early 2026 Council meeting.



Draft Community Improvement Plan Review

Council received a report on the Draft Community Improvement Plan Review. Council directed staff to bring a report back to a meeting in early 2026 with decision options to begin the process of implementing a community improvement plan to support priorities such as downtown revitalization within this term.

Confirmation of 2026 Meeting Calendar

Council received a report on the 2026 Meeting Calendar. Council approved the following 2026 meeting calendar:

- The regular meeting of June 9, 2026, be moved from Town Hall to South Fredericksburgh Hall.
- The regular meeting of September 8, 2026, be moved from Town Hall to Roblin Hall.
- The regular meeting of October 27 be cancelled for the election.
- The inaugural meeting of the 2026-2030 Council be held on Tuesday, November 17 at 1:00 pm and any special meetings for the 2026 budget in January be scheduled at a later date.
