Regular Meeting of Council for September 24, 2024

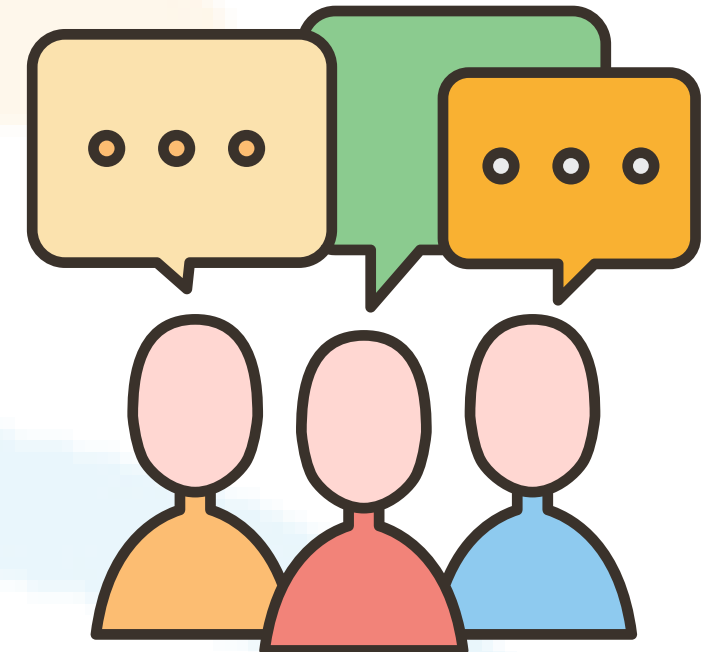
## AFHS Road Signs Project

Council received a report on the AFHS Road Signs Project. Council endorsed the project and approved in-kind support in the amount of \$6464.07 for the equipment and labour to install the signs on municipal property.

## Downtown Advisory Committee Follow Up

Council received a report for information on the Downtown Advisory Committee Follow Up. Council will delay a decision on whether any committee is needed to replace the Downtown Advisory Committee pending completion of an advisory committee review and guidelines by the CAO, communications policy, and events policy.

Council also approved one-time funding of \$5,000 for the Downtown Shopping Party from funds remaining from the Downtown Advisory Committee and allocated the remaining funds towards the additional grant amount approved for the Seniors Outreach Service under Council Resolution #312/24.

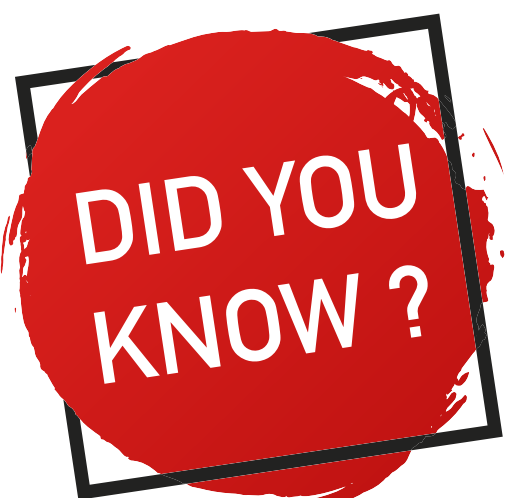
## By-laws

- By-law No. 2024-0057 - to Provide that Subsection 50(5) of the Planning Act, R.S.O. 1990, Chapter P.13 as Amended does not Apply to Certain Lands

### Community & Corporate Services

Areas of discussion included equipment and vehicles that were sold on GovDeals, the painting of Town Hall that was completed on September 27th, upcoming events, ongoing community consultation for budget and an encampment response, new rink board advertisements, and the testing and refinement of the CCTV camera systems that has continued in collaboration with the OPP. ### Executive Services

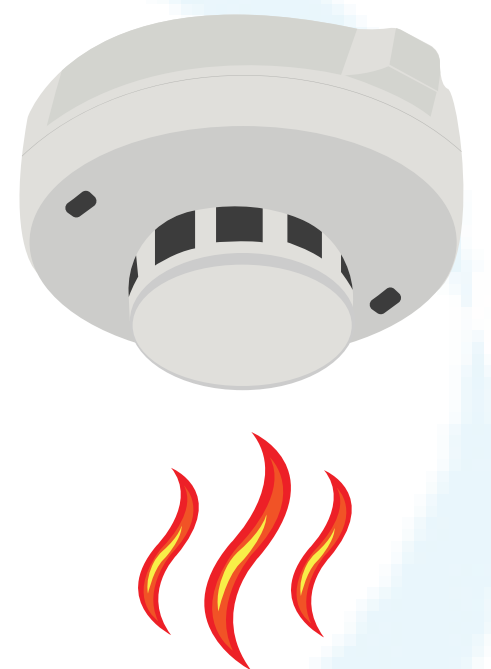
Areas of discussion included a CAO / Clerk's Forum by the Ministry of Municipal Affairs and Housing on October 1st at the Best & Bash Arena, an update on open and filled positions within the organization, extended hours under the supplemental by-law enforcement contract to ensure continuation of by-law services in the interim, and an update on by-law reporting statistics. ### Financial Services

Areas of discussion included the 2023 year end audit that began on September 23rd, 2025 budget planning that is underway, PSD Citywide Assets implementation that has started, and the Accounts Payable listing for the period of August 16th to September 17th. ### Fire Department

Areas of discussion included the department's participation in upcoming events, Fire Prevention Week from October 6th to 12th, fire safety lessons that staff are providing to local organizations, and discussions with the Paramedic Chief and their Deputy Chief at the County to review the components of the Tiered Response Agreement between the Town of Greater Napanee and Lennox & Addington County. 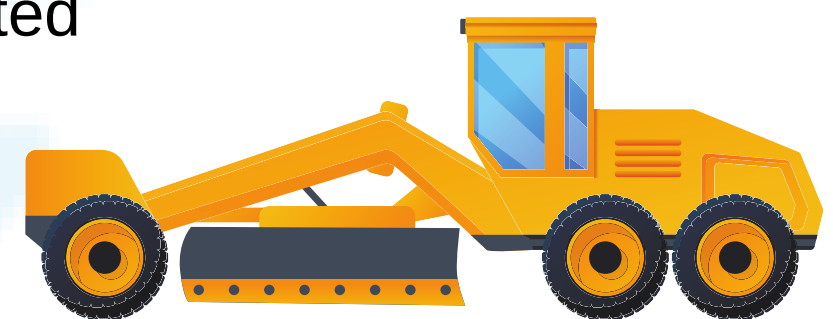


### Growth & Development Services

Areas of discussion included a funding application for the Housing Enabling Water Systems Fund (HEWSF) that was successful and will provide \$34.8 million for an upgraded and expanded Water Pollution Control Plant, and updates on various projects such as the Atura Battery Energy Storage System (BESS) Phase I, Richmond Mobile Home Park Phase III, and Springside Meadows Subdivision. ### Infrastructure Services

Areas of discussion included surface treatment that is complete for 2024, grading that began the week of September 9th for gravel surfaced roads, work that is being completed on 2024 Utilities Capital projects and preparation for the 2025 budget, and upcoming external scheduled audits on the Town's Drinking Water Quality Management System (DWQMS). 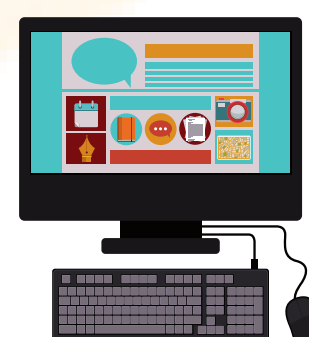

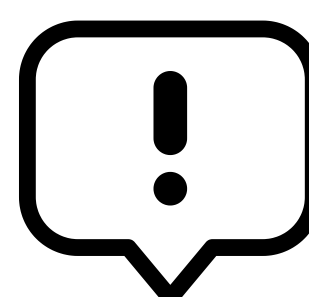
