Application for a Permit to Construct – Tent

Application Requirements

To apply for a permit to construct, the following is required;

- > Complete Application for a Permit to Erect a Tent.
- Detailed construction plans to include dimensions, materials, assembly and anchorage.

Drawings must be pdf or if paper, no larger than $11'' \times 17''$

- > Tents over 225 square metres require engineering.
- Plot Plan. This is not a survey but is a rough drawing, showing the location and size of the proposed structure and its' distance to all lot lines, road, water way, if applicable (including creeks and swamps), all other existing structures (including house and outbuildings) and septic system, if rural.

Depending on the location and nature of construction, the following may also be required;

- > Written approval from governing agencies. (ie MTO, Conservation Authority)
- Agent of Record Letter form, filled out and signed by property owner and applicant, authorizing the applicant to apply for a permit on behalf of the property owner.
