Regular Meeting of Council for November 9, 2021

#### 2021 - 2022 Warming Centre Update:

A committee of 18 people, including 1 member of Town staff, has been created to help bring a warming centre to the community. This committee will meet once a week until the warming centre has been open. The location of the warming centre will be at the Morningstar Mission (59 Water St W).

### **What's Happening in Our Municipal Departments:**

# Request for Expressions of Interest (REOI) - Vendor of Record for Municipal Real Estate Transactions:

In July 2021, the KPMG report Review of Property Sales Process – Specific Properties recognized the value of the Real Estate Pilot Project and recommended that the Town should consider implementing the pilot program of using a real estate agent for disposition of Town properties. The Town will be utilizing the services of Rogers & Trainor Commercial Realty Inc. Brokerage under the conditions prescribed in the REOI document issued on September 22, 2021. #### **Telecommunications Towers:**

Council directed staff to write a letter to Xplornet stating that the Town cannot accept Xplornet's current proposal regarding the location of the proposed 50m tall self-supporting telecommunications tower in Selby. Council does support the initiative to bring internet access and a telecommunications tower to the Selby area but wants to discuss alternative location options with Xplornet for the tower.



Council supported the proposal for installation of a 91.5 m tall guyed Rogers telecommunications tower located 50 m east of Fitchett Road.

#### Adoption of By-law to Appoint John Pinsent as the Town of Greater Napanee's CAO:

Council introduced <u>By-law 2021-0051</u> to Appoint John Pinsent as the Town of Greater Napanee's CAO. This by-law sets out the framework of delegated authority for the CAO, in coordination with all other established by-laws and policies of Council. The primary purpose of this by-law is to provide clear communication to Council, staff and the public about the expectations of the CAO and the CAO's role within the organization. The by-law will return to the November 23 meeting for adoption.

The 2021 Parade of Lights will be held on Saturday, December 4 beginning at 5:30 p.m. All event information is available on the <u>Town's website</u>.




Local businesses, community organizations and groups are encouraged to enter a float in this year's parade but submitting a <u>Parade of Lights Float Registration</u>
