## Council Highlights

Regular Meeting of Council for October 24, 2023

### Deputation - Atura Power

Council heard a deputation from Atura Power regarding a Napanee Generating Station expansion and battery energy storage system. Council will consider the request for a municipal support resolution at the regular meeting on November 14th.

### Louis Riel Day

Council proclaimed November 16, 2023, as Louis Riel Day in the Town of Greater Napanee.

### Industrial Community Improvement Plan

Council approved the Draft Industrial Community Improvement Plan (CIP) with the addition that the Draft CIP includes a sliding scale grant system to include projects valued below 10 million dollars as described as an alternative option in the staff report. The Industrial CIP will be brought to the November 28, 2023, regular meeting of Council for adoption. - By-law No. 2023-0068 - A By-law to Adopt a Community Grants Policy for the Corporation of the Town of Greater Napanee

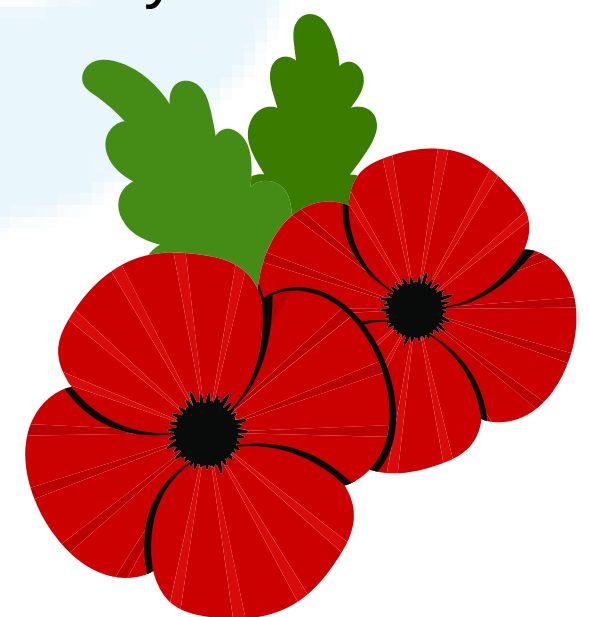
### What's Happening in Our Municipal Departments:

## Special Meeting of Council for October 26, 2023

### Waste Diversion Committee Recommendations

The Waste Diversion Committee [Report](#) brought forward 17 recommendations for ways to help Greater Napanee move from its current diversion rate of 32% to the provincial target of 50% by 2030. These included exploration of a future organics program, increased community education and engagement, and extending the life of the landfill through initiatives like a re-use site.



Council directed staff to bring multiple funding options for waste collection to the draft operating budget meeting in November for further discussion.

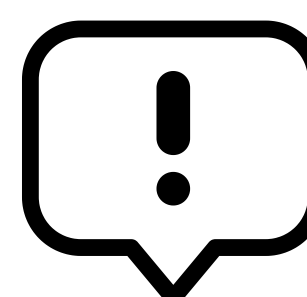
